"Welcome wagon" topic with Cheryl Crowe & Melaney Dittler

Proposing a "Liveability Committee"

Goals: increase involvement of neighborhood residents, fun events/activities to help people meet their neighbors

Started with idea of welcome wagon, involved into giving new residents information about the BAC and practical neighborhood advice

Could end up being the channel for neighborhood event planning to focus that task among folks who enjoy event planning

Example: make leaf pickup into a volunteer activity. Pick 2 days during the fall, perhaps 1 before Halloween to make it easier to trick or treat, the other before Thanksgiving to clean the neighborhood for that holiday

Would like to create a social media calendar for awareness of events

Community Map a part of the effort, start with something easy to make and make it more professional looking as it's developed. Cheryl's received a list of "interesting" neighborhood locations, with things like the Little Free Libraries.

Positive reactions to the idea from local businesses, like Pizza Doughnais

Some folks have signed up to the idea of the committee

Would like to propose an "art therapy" event. Plan a socially-distant get-together in September. Want to reach out to all Brooklyn apt building owners to get notifications of new tenants so we could get them information. It's easier for house sales.

Trying to get to the point where residents tell new residents to expect a packet, becomes a feature of the neighborhood like the historical Brooklyn house plaques.

Important to approach new residents within something like the first 6 months because they're more likely to get involved.

Guy: will it have information about active issues, like River Access & land use

Melaney: of course, but will need to be continually updated.

Cheryl: have links to PDFs on the website, Kimberlea suggested a Google request form to get a packet.

Josh: shy away from "Liveability" as it has some negative connotations

Marie likes Welcome Wagon Leah: "Community Connect" "Community Connections"

Josh: must clearly delineate the responsibilities so that it's apparent when a particular committee has the mission to undertake something. Minimize conflict over who does what.

Leah reiterates the NIMBY, anti-houseless, anti-Black connotations of "Liveability". NextDoor has a mapping tool that may be useful to the committee. SE Tool Library as a resource.

Stuart: Is there a budget estimate, maybe just an initial one?

Melaney & Cheryl have thought of it, but haven't gotten any printing estimates yet. If the initial rollout shows an increase in participation, that makes a good basis for a grant application. Reminder that many of the offers will be paid for by the orgs/companies donating it.

Josh: clear that no expenses covered until we get board approval for budget and the content being distributed.

Kimberlea: ESJ would like to get content included on social justice, etc. Be aware of the sustainability of the items we're distributing.

Josh: get the finalized proposal & budget before the board for approval prior to moving forward.

Motion to start the process of doing this committee Josh moves, Tim Walsh seconded Approved by acclamation, no abstentions, no nays.

Back to the motion to admit JK

Some discussion about two folks from the same household on the board. Tom Vinacci raises the concern, particularly about side conversations within the same household, collusion, etc.

Leah says it's not necessarily in any bylaws, and there are other orgs that have partners from the same household on the board. The orgs are "participatory organizations", so the org can decide how representation works. As long as it doesn't violate bylaws, it's allowed. Might be good to rethink the rule if partners start crowding the board to the limit of membership.

Discussion around the ethics/appearance of multiple family members on the board.

Cheryl volunteers to step down if JK gets confirmed? (Is confirmed the right word)

Voting: acclamation, no abstentions, no nays Cheryl resigns (or Tim kicks her off?)

Next agenda item: Grants & funding updates

Communications grant: translation services and other tasks that might be too time-consuming for volunteers. It's in the pipeline, still waiting for news.

Small Project grant: email exchanges over it in the last few days.

Josh: some tension in those discussions over the small project grant

Leah: might be appropriate to take advantage of some mediation services available via the Office of Community Life

Josh: clarification of rules of engagement for working sessions vs meetings when policy is decided, notice requirements and such.

Leah: forming the group, hoping to award early April or by the 4/21 depending on how that scheduling goes.

Kimberlea: acknowledging that people were harmed and that should be addressed.

Agreement by others that there was some harm inflicted on all side.

Josh: points out that we should acknowledge it. Doesn't want to unpack it now. Comments in the chat (which I'll save and append to this) about taking some time to discuss this separately.

Josh: Budget appears to be incomplete, worries about the degree of negative cashflow in the upcoming year. Starts sharing the budget, will need to clean up doc before sharing.

Melaney: Loves the idea of a budgeting money for snacks & such during meeting, but we've never really needed to pay for that before, folks have just brought them. No expectation that they should be bought by anyone.

Josh: true

Marie: agrees with Melaney on snacks. Questions the \$120 for Flyers. Worrying about flyers on the telephone poles.

Josh: wants to move on.

Kimberlea: briefly talks about take up / take down from poles. Equity discussion around the social impact of accepting free snacks from folks. Someone asks, should the board pay. It does make the board more welcoming.

Josh: the budget should reflect priorities. Wants to make sure we vote on it at the next meeting.

JK makes point about some costs around website, phone, etc. that may be cut by using Google Apps for Nonprofits

Josh: will circulate this with the goal of approving this at the next meeting.

Timothy: has checkbooks/registers so he can get accurate expense numbers.

Marie: wants to join the board. Agreed to add it to the top of the agenda at the next meeting.

JK not officially voted in as secretary, will do that next meeting

Wesley Ward on the diesel issue. There's a bill forward to reduce diesel pollution. Will take 5y to implement, and it's weaker than we hoped. Can email wesleytward@comcast.net for details on the history of the issue. New opportunity to regulate indirect sources of pollution, like the railyard, shipyards, ports, warehouses. DEQ currently doesn't regulate them, and it will be opposed by industry groups. Currently 3 bills:

- one would enable regulation of the indirect sources.
- Another would provide funding to fix older diesel engines, or get them retired. WA & CA
 have done this with some success. Would be funded by a tax on things they need, like
 tires.
- Kevin Downey (sp)'s proposal to add black carbon as an official greenhouse gas, as it's an aerosol. It's 1500x more warming than CO2, but it's short term. This would make it part of an official policy to reduce greenhouse gases.

Drafted a letter for us to approve.

Josh: clarifies legislative roadmap for bills. Proposes provisional support for the letter, prior to referring to committee for approval.

Marie: wants details for newsletter.

Tom: unless there's funding, this harms diversity because BIPOC individuals & small business owners will be impacted the most.

Wesley and Josh point out that the letter calls out an assumption of funding support for BIPOC individuals, businesses and etc. Wesley gives example of retiring diesel schoolbuses.

Guy: points out the larger impact on BIPOC folks of these issues.

Jone: wants clarification on the process.

Lots of discussion around the process.

Josh: Finally decision we will refer to Land Use and Transportation committee to draft the letter for the board to vote on at the next public meeting. Get the letter to the board 5 days prior to the meeting. Vote: all in favor, no abstentions, no oppose

Wes offered to talk at the general meeting prior to our vote.

Discussion of upcoming meetings deferred, as nothing's changing.

Cleanup events

General meeting in 2 weeks with new vote.

Melaney proposes getting a state rep to the meeting in 2wks. Rob was at the Jan meeting, so decided it's OK to not have one.

Vote on January meeting minutes:

Josh says one small correction. Vote to approve with the correction. Vote: all in favor, none abstaining, none opposed.

Barbara and Melaney: Food and Hygiene drive this Saturday at Brooklyn Park. Please attend. Adding hygiene products. Would love to get check for groceries for grout. How much more of the match is available?

Let's do a social media reminder.

Reach out to Cleveland to see if students there who are Brooklyn residents want to participate. Melaney: criteria are a 1 year commitment, resident of Brooklyn, 15 & up

Tom: limited to Cleveland?

Kimberlea: add it to the newsletter

Marie: send it to her

Some discussion as to whether we're advertising specifically for a youth seat? It's not that we're reserving a youth seat, which requires a change to the bylaws, but that we recruiting a young person to take that seat.
