

# Neighborhood Cleanup

Discussion of a September dumpster cleanup by Melaney \$250/dumpster current price,
Usually do 4 with one a yard debris, but may just do 3
\$110/ton for dump fees
Usually do 8-9 tons
About \$1700 total

Discussion of how much money we have this year vs prior year. Missing some city money.

Suggestion that businesses can sponsor a dumpster Melaney would sponsor one. Personal contributions would manage the others.

Josh: figuring out if what we collect from individuals Marie thinks we get about \$1K from individuals

Charge \$40/50 carload Varies on size of the load

Can separate scrap metal and turn that in for \$\$\$

Question from Kimberléa: how's it run for recycling

Marie: rummage sale

Melaney: no recycling, since folks can do that, but the possibility we could do styrofoam

Discussion of newsletter/comms schedule for promotion
We have two newsletters coming out before a projected September/October date
November ruled out because cold/rainy and folks might bring yard waste.

Discussion of excluded items: construction debris and a list from heiberg

Classic Pianos will probably donate their truck for metal recycling and buy a dumpster. Kimberléa asks about partnering with Ridwell for some recycling, clamshells, batteries, light bulbs

Discussion of another cleanup, perhaps on the perimeter, before the Sept/Oct date.

Kathy: we have gloves, SE uplift can loan us 20 grabbers with a week's notice

Marie: 2 weeks from a late June drop date for most newsletters to be distributed

Josh: seems like a 3rd week of July date

Melaney: 7/31-8/1

Marie: needs copy for the newsletter.

## Diesel bills

Some of the bills didn't make out of committee, Indirect sources (HB2814) did make, recommended that we send a very similar letter to the same parties.

Should we ask for the bill to be changed? Unknow

The letter we send should say exactly what we said before because time is limited

Wesley Ward joins the chat.

Jone: So did I just miss the link to the OR DEQ grants for small(er) freight companies which I thought was going to be published in this newsletter?

Wesley: didn't require legislation, was a continuation of a previous program.

It's for retrofitting diesel trucks, so could apply to current folks. Could apply to Fred Meyers.

Will put a short thing in the next newsletter

Wesley will write a paragraph and mention the grant program that starts 6/30 closes 8/31

Welsey summarizes the struggle around HB2814. DEQ resisted being directed to do regulation of indirect sources because of expertise problems in OR. Now directed to do a study on how to make it happen.

Now in a house subcommittee while a \$500K cost item to do the study is debated. Seems large to Wesley. He thinks it might be compromised to metro only area pollution.

Maria asks about the number and emissions from UPS and Fedex trucks. Wesley and Don tried to do a survey of license plates to see when peak times are happening. Comments on the trucks that are seen around here that are actually registered in Indiana. Bill wouldn't affect them.

2479 is the black carbon bill, may strengthen the DEQ. Wesley will draft a letter on that if needs one one.

2814 still needs a letter, can send the same one.
