We start this event by acknowledging that Multnomah County is geographically located on the ancestral homelands of the Indigenous tribes of the Multnomah, Kathlamet, Clackamas, Tumwater, Watlala bands of the Chinook, the Tualatin Kalapuya and many other Indigenous nations of the Columbia River. We recognize that Indigenous/Native American communities still exist today despite intentional attempts of genocide, displacement, and assimilation by white supremacy culture and systems.

While land acknowledgements are important in helping us frame a sense of place and history, we recognize that they are only the first step towards reconciliation.

Communications Policies Task Force formation

The goal of this task force would be draft a set of practices and policies for maintaining a uniformity of messaging across all channels—social media, print, email, etc. This is both a document embodying editorial policies and goals as well as how-to for each channel.

This proposal is for the Board to create this force and ask them to return in the fall (September or October) with a draft for discussion by the board with the goal of voting on adopting the communications policy document as soon as possible.

Accessibility Statement task force formation

Not discussed

The purpose of this task force is to draft an actionable accessibility statement and framework to use for all our meetings. The statement should provide a process for the BAC to make reasonable accommodations for anyone with an impairment to attend a BAC meeting or event. This proposal is for the Board to create this force and ask them to return in September with a draft for discussion by the board with the goal of voting on adopting the accessibility statement by October.

Community technology task force formation

BAC has a technology platform that doesn't allow us to efficiently keep records or publish communications. The purpose of this task force is to create requirements, find solutions, and get pricing for BAC technology needs for our everyday communications, clerical, and administrative needs.

This proposal is for the Board to create this force and ask them to return in October or November with a proposal and recommendations for discussion by the board with the goal of budgeting for a recommended solution in the 2023 budget year.
