

We start this event by acknowledging that Multnomah County is geographically located on the ancestral homelands of the Indigenous tribes of the Multnomah, Kathlamet, Clackamas, Tumwater, Watlala bands of the Chinook, the Tualatin Kalapuya and many other Indigenous nations of the Columbia River. We recognize that Indigenous/Native American communities still exist today despite intentional attempts of genocide, displacement, and assimilation by white supremacy culture and systems.

While land acknowledgements are important in helping us frame a sense of place and history, we recognize that they are only the first step towards reconciliation.

- TriMet 2023–2024 service change proposal: Josh Hetrick will Submit a comment on behalf of BAC in general support of the proposed changes to the #19, #70, and #66 buses. Include a caveat that while moving the #19 off from the Ross Island Bridge to Tilikum Crossing is good overall and should help to avoid congestion-related delays, it does remove some useful service from the west end of the bridge. There may need to be other service changes to continue serving that area effectively. Comment due by Fri Feb 10.
 - Motion to approve Yes 8, No 0, Abstain 0, Absent 1
- **EPA proposal to tighten allowable levels of PM 2.5 particulate:** Support, and encourage setting the limit at the lowest end of the proposed range (or even lower). Comment due by Mar 7.

- Emerging state legislation: There are 3 bills, highlighted by Wes Ward at the January general meeting. In short, they deal with: regulating indirect sources; more funding to transition from the oldest/dirtiest diesel engines; and adopting an environmental justice lens for future developments or activities. These bills aren't finalized yet, but even if we aren't ready to officially endorse any bills we should discuss them to see if we have general consensus on the topics.
